Hello.

We live on a very fast and dangerous piece of road along with many other residents. The section of road is Waikawa Beach Rd between SH1 and Takapu Rd which is straight, narrow, undulating and without footpaths or safety barriers.

There are now many dwellings along this stretch of road, all with driveways and sections only metres from it. Add to this the significant increase in traffic volumes that use it to access properties and developments further down the road.

The current speed limit is 80km/hr and even at that speed, a collision with other vehicles, pedestrians and cyclists would cause major injury or death. Unfortunately, most local drivers well exceed this limit thus increasing that risk.

The road surface itself is rudimentary and course. The high traffic volumes and the high speeds coupled with a poor road surface generates a significant amount of road noise pollution. This has increased year on year since I moved here over 20 years ago and is mainly due to the high level of property development that has been allowed to occur.

We ask that the speed limit is reviewed and reduced to 60km/hr or less for this section of the road at least.

## IT'S TIME TO SLOW WAIKAWA BEACH ROAD

Horowhenua District Council are seeking submissions in response to their "Draft Speed Management Plan 2024-2034".

This plan can be viewed on their website or social media and submissions close 5pm 21 August 2023.

### Background.

The section of Waikawa Beach Rd between SH1 and Takapu Rd is straight, narrow and undulating.

There are no footpaths, median or edge barriers. Cyclists, pedestrians and their animals must share the narrow traffic lane with all vehicles including large, heavy vehicles.

There are many rural residential properties along this section of road, many with dwellings, sections and driveways only metres from it. In fact, much of the road now resembles an urban street.

The current speed limit is 80km/hr

### The Problem

When considering the facts, it is obvious that the current 80km/hr speed limit is too high. Consider this also with the propensity of many drivers, mostly local, to regularly exceed this, often by a significant margin.

Traffic volumes have increased significantly over the last 20 years. So too has the number of residents and other users along our street. The speed limit and driver behavior needs to now match these statistics.

The current situation is not only very dangerous, it has also created significant noise pollution, exacerbated by high speed and course road chip

### What Can We Do?

The best way to implement change is to collaborate. Here are some ideas:

1. The maximum speed limit for this part of the road should be reviewed and reduced to 60 km/hr. Go to the HDC website or Facebook page and submit ideas to the "Draft Speed Management Plan"
2. Work with our community Police to educate drivers and enforce speed limits
3. Lobby council to introduce traffic calming measures and to improve the road surface in keeping with population density.
4. Work with council and property owners to enhance the area through the installation of footpaths / cycle ways and plantings.

### **Proposed speed limits around Fairfield School**

Kia ora/Hello

I have read your web pages about reviewing and, in most cases, lowering speed limits in the vicinity of schools.

**I totally oppose the proposed imposition of a 30km speed limit in Highbury Drive, Levin.**

Your web pages give no supporting evidence for the proposed speed limit change in Highbury Drive.

No figures, for example, are quoted about the level of usage of Highbury Drive by people associated with Fairfield School, the percentage of Fairfield School pupils using Highbury Drive to access the school, or the number of road traffic incidents in Highbury Drive.

More importantly, no mention is made of the absence of any people associated with Fairfield School outside the pupil delivery and pickup times, yet the implication is that the reduced speed limits are to be applied for 24 hours per day, including school holidays.

No figures are given to show the current average car speeds in the Highbury Drive cul-de-sac.

No mention is made of the inconvenience suffered by residents of the cul-de-sac at the top of Highbury Drive by parents and caregivers parking over driveways and failing to use the car's indicators when arriving and departing, which is a hazard for other motorists and pedestrians.

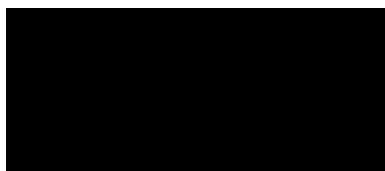
As well as speed, any safety measures should look at all contributory factors. Of those, driver training and behaviours should be considered as equally important in the Highbury Drive case.

There is also a quick and 100% effective solution that does not involve changes to speed limits and associated paperwork and signage - close the Highbury Drive cul-de-sac entrance to Fairfield School.

This will remove all potential dangers on the road and remove a major inconvenience for residents. This measure will also discourage unauthorized people using the school's outdoor facilities outside of school hours.

This measure will also reduce the ever-increasing fiscal burden on Levin rate payers.

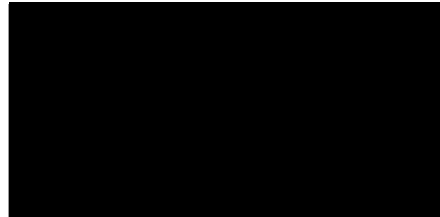

### Proposed Speed Limits around Fairfield School

I have read your web pages regarding reviewing and, in most cases, lowering speed limits in the vicinity of schools. Please note that the organization mandating your review is Waka Kotahi NZ Transport Agency, not Waka Kotahi. Please respect the major language of New Zealand.

I totally oppose the proposed imposition of a 30Km speed limit in Highbury Drive, Levin. Your web pages give no supporting evidence for the proposed speed limit change in Highbury Drive. No figures, for example, are quoted regarding the level of usage of Highbury Drive by people associated with Fairfield School, the percentage of Fairfield School pupils using Highbury Drive to access the school, nor of the number of road traffic incidents in Highbury Drive. More importantly, no mention is made of the absence of any people associated with Fairfield School outwith the pupil delivery and pickup times yet the implication is that the reduced speed limits are to be applied for 24 hours per day, including school holidays. No figures are given to show the current average car speeds in the Highbury Drive cul de sac.

No mention is made of the inconvenience suffered by residents of the cul de sac at the top of Highbury Drive by parents and guardians parking over driveways and eschewing the use of car indicators when arriving and departing.

It seems that the review of speed limits in the general vicinity of schools is yet another manifestation of the apparent ideological fixation by Waka Kotahi NZ Transport Agency on speed as the cause of all roading problems rather than looking at all contributory factors. Of those, driver training and behaviours should be considered as equally important. In the Highbury Drive case, there is a very quick and 100% effective solution that does not involve changes of speed limits and associated paperwork and signage - close the Highbury Drive cul de sac entrance to Fairfield School. This will remove all potential dangers on the road and remove a major inconvenience from residents. It will also reduce the ever-increasing fiscal burden on Levin rate payers.

### ***Background***

Thank you for the opportunity to provide feedback on the Horowhenua District Council Speed Management Plan. The Ministry of Education ('the Ministry') is the Government's lead advisor on the New Zealand education system, shaping the direction for education agencies and providers and contributing to the Government's goals for education. The Ministry assesses population changes, school roll fluctuations, and other trends and challenges impacting on education provision at all levels of the education network to identify changing needs within the network so the Ministry can respond effectively.

The Ministry has responsibility for all education property owned by the Crown. This involves managing the existing property portfolio, upgrading, and improving the portfolio, purchasing, and constructing new property to meet increased demand, identifying, and disposing of surplus State school sector property, and managing teacher and caretaker housing. The Ministry is therefore a considerable stakeholder in terms of activities that may impact existing and future educational facilities and assets in Horowhenua.

### ***Land Transport Rule: Setting of Speed Limit Rule 2022***

As part of the nationwide programme under the government's "Road to Zero" National Road Safety Strategy, all councils must review their road speed limits. The aim of the review is to reduce the number of serious injuries and fatal crashes on New Zealand roads by setting safe and appropriate speed limits that better match the road environment. One of the key actions in the Road to Zero Strategy is to set safe speed limits around all schools by the end of 2027, with an interim target of 40% of schools by 30 June 2024.

As part of this strategy, Waka Kotahi released a new 'Setting of Speed Limit Rule 2022' ('the Rule'). The new Rule sets out new requirements and acceptable speed limits near schools, with the aim of making walking and cycling to and from schools much safer. The new Rule requires councils to set a permanent or varied speed limit of 30kph outside Category 1 schools (urban or peri urban schools). The Rule requires schools identified as Category 2 to have a maximum speed limit of 60kph (or less). Category 2 schools include rural schools where there is no associated pedestrian activity in the road environment (including off-street pick-up and drop-off for all vehicles, including school buses).

### ***The Ministry's feedback on the Speed Management Plan***

Horowhenua District Council ('the Council') has notified and is seeking feedback on its Speed Management Plan which proposes to reduce the speed limit of roads adjacent to schools located within the Horowhenua district. This is in response to the Rule and the reduction of speed limits around schools and is consistent with the Road to Zero Strategy 2020-2030.

The Ministry is supportive of the proposed speed limit reductions around schools throughout the Horowhenua district. The speed limit reductions proposed by the Council will provide greater safety for students during pick-up and drop-off times during school days as well as members of the public using school facilities outside of these hours.

The Ministry has consulted with the above-listed schools regarding the proposed changes. No specific feedback has been received from the schools at this point, but this will be forwarded to Council as it is received. The Ministry encourages engagement with the schools will ensure that the proposed changes will achieve the safest outcomes for each school and identify any risk points within the roading environment that need to be considered.

Regarding the options presented for Foxton Primary School and Manawatū College, the Ministry is in support of Option 1 – permanent 30km/h limit – for both schools. The Ministry would prefer to see consistency across the district and given that the Plan proposes reducing most school zones to a permanent 30km/h zone, the Ministry supports the permanent speed limit option for these two schools. Consistency makes it easier for vehicle operators to navigate the roading environment around schools which keeps children, and others accessing school facilities, safer.

It is noted that traffic calming infrastructure is proposed to be developed in subsequent stages of the Plan. The Ministry would like to be informed about these proposed interventions as they are developed, as they are key to ensuring that vehicles adhere to the posted speed limits. Furthermore, the Ministry would encourage Council to work with each affected school in the design and implementation of this infrastructure, as each school is likely to have different requirements and issues that need to be addressed.

Lastly, should the Council opt for variable speed limits around some of the schools, the Ministry would encourage Council to work with the affected schools directly to understand what hours should apply to the



variable speed limit. Applying a blanket window of time may not work for all schools as they may have different start and finish times, reflecting in different peak hours for pick-up and drop-off.

My particular concern is with the proposals to change vehicle speeds at Waikawa Beach. I approve of reducing speeds around schools.

I agree with the proposed speed limit changes in Waikawa Beach, with some changes.

## Changes or suggestions for the proposed speed limit changes in Waikawa Beach:

Waikawa Beach is a curious case because of its nature. For much of the year it's very quiet and the current 50 Kph limit for most of it is completely suitable.

Many locals are considerate drivers who move aside, slow down and take care around pedestrians (with or without dogs and children), horses and cyclists.

Over Easter, Labour weekend and especially for about 3 or 4 weeks over Christmas things are very busy. There is an influx of people who aren't here very often (there are quite a few B&Bs with an ever changing roster of visitors).

At those times it's common to find kids riding bikes all over the road, folks wandering around with kids and dogs, also all over the road.

At those times 30 Kph would be more suitable.

Moreover Strathnaver Drive and Reay Mackay Grove are a bit the same but also different. Both are currently 60 Kph. At the busy times of year Strathnaver Drive is also busy with cyclists, runners, pedestrians and horses.

What's more, the end of Strathnaver Drive closest to Reay Mackay Grove is a place where there are two Significant Natural Areas (the Strathnaver lakes, Waimarie and Te Puna a te Ora) which at all times of year should see speeds limited. The highly endangered, Nationally Critical, Manku-hiropo, Australasian Bittern bird is seen from time to time around these lakes. Speeding vehicles pose a risk to these birds.

Also, Strathnaver Drive has 3 speed bumps. It's almost impossible to actually achieve 60 Kph without accelerating and decelerating suddenly, creating noise (yet people try) because of the combined speed bumps and curves. Once the road straightens out it comes into the area I mentioned above where lower speeds are more appropriate.

The Strathnaver area is currently experiencing a lot of growth — many new houses have been built in the last few years — so traffic has increased with residents and also all the many contractors involved in building. There are more sections where houses could yet be built.

It seems inappropriate to reduce the speed on Reay Mackay Grove to 30 Kph without also reducing the speed along Strathnaver Drive, perhaps to 50 Kph.

I would suggest the speeds for both Strathnaver Drive and Reay Mackay Grove should be reduced to 50 Kph, rather than 30 Kph for Reay Mackay Grove and leaving Strathnaver Drive at 60 Kph.

If the roads in the village are to be reduced to 30 Kph then both Strathnaver Drive and Reay Mackay Grove should EITHER be reduced to 30 Kph, which would provide an easy consistency in speeds for all drivers, OR Strathnaver Drive and Reay Mackay Grove should both be set at 50 Kph.

It would also be very helpful for the 3 speed bumps along Strathnaver Drive to be removed completely. They are a menace for cyclists, have little relevance since the speed along Strathnaver Drive was reduced from 100 Kph a few years ago, and the curves in the road already reduce the speed drivers can travel at.

In addition, HDC is also responsible for the road along the beach. A few years ago the speed was reduced from 100 Kph to 30 Kph. That has been a blessing. However, I'd like to see a further speed change that requires slowing down near people, along the lines of the Waimakariri District Council policy at <https://www.waimakariri.govt.nz/environment/beaches-and-sunbathing>.

"Speed limits apply, you should drive no faster than 30km/h and slow down to 10km/h when within 50 metres of people"

I would like to see Horowhenua District Council develop a full policy regarding vehicles on beaches. That policy should ban motorbikes completely as Kāpiti does. See [Vehicles on the beach - Kāpiti Coast District Council] <https://www.kapiticoast.govt.nz/Our-District/Beaches/Vehicles-on-the-beach/>.

"Two wheeled and off-road motorbikes are not permitted on any beach, foreshore or dune areas."

The policy should also set expectations around reducing speeds when near people (and animals such as dogs, horses and seals) and reinforce existing requirements about where exactly vehicles may and may not travel on the beach, legal requirements such as drivers being licensed and so on.

Please make more provision for cyclists — everywhere.

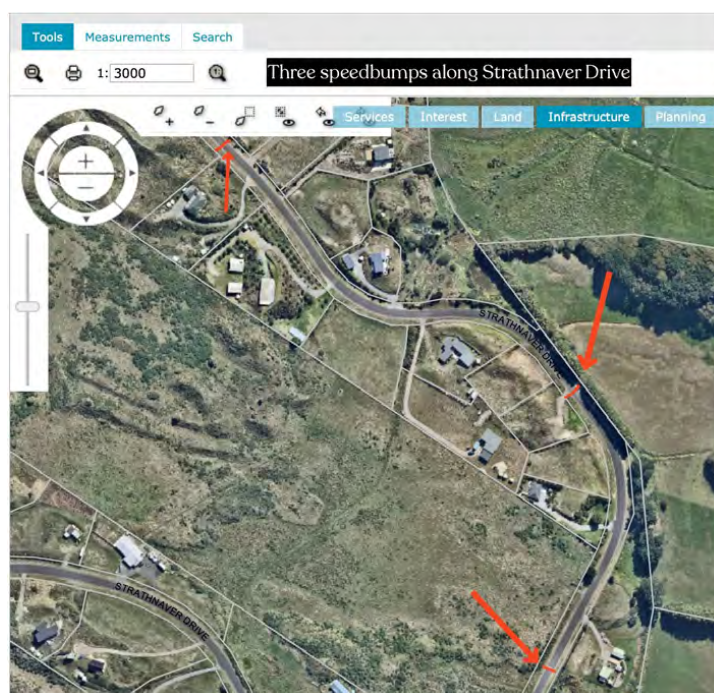
Please also publicise where trailbikes may be used (is there a dedicated riding venue for them?) so that we can redirect them from making a nuisance of themselves on the beach (and endangering the public) and in public areas of Waikawa Beach.

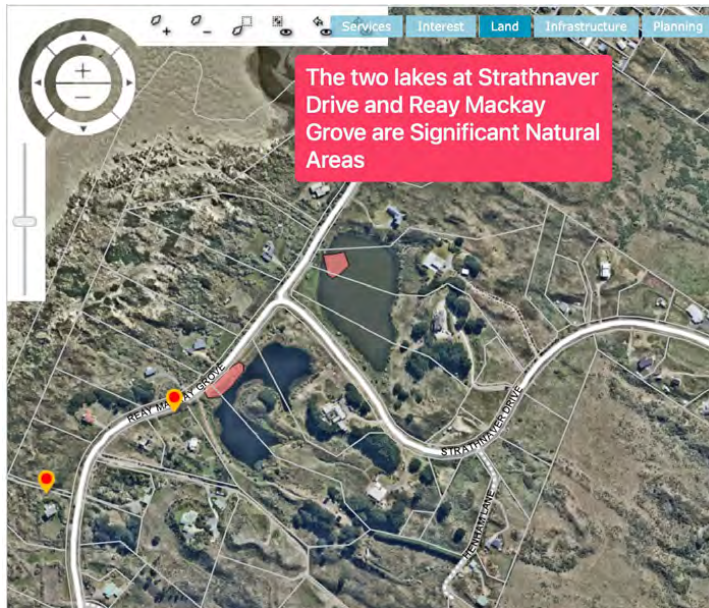
I would like to see all these changes implemented as soon as possible.

## Destroying dunes, endangering everyone

Published at 14:06 on 18 April 2023



Marked areas are roughly where, 5 years on from the photo date, new dunes are growing and birds nest in season.

Motorbike and quad bike racing, ripping up the dunes – bad behaviour by a few over the Easter holidays was damaging and dangerous.

Between the sea and the settlement of Waikawa Beach lie the sand dunes. Grasses such as Spinifex, Pingao and Marram help hold the sand, binding it in place. Spinifex and Pingao in particular reach out towards the sea and help grow the dunes laterally.

The dunes help protect the settlement and provide habitat for birds and other animals to nest and breed and live.

In turn, driftwood helps protect the dunes and collects sand and provides shelter for wildlife.

The area roughly marked on the aerial photo at the top of this post is on the seaward side of where an enormous investment of time, money and energy has gone into planting native beach grasses in the last decade. That area is commonly home to Pied Oystercatchers, South Island Oystercatchers, Pied Stilts, Banded Dotterels, New Zealand Dotterels and others

In the last 5 years in particular new dunes have started to form and be held together by grasses, both planted and self-seeded.

This growth is encouraging and important. It enhances Waikawa Beach and deserves protection. Most people find it an easy area to avoid – walking or driving past.

So it was utterly disappointing to discover that during the Easter school holidays numerous vehicles (or perhaps a few vehicles numerous times) had driven through and between the new dunes, across the summer bird-breeding area and even over the tops of the young dunes, sometimes ripping out chunks. There were clearly tracks from motorbikes and from 4-wheeled vehicles, some very heavy.



Criss-crossing and circular tracks, layered one on top of another show this wasn't someone just passing through, but a deliberate use of the area as some kind of vehicle playground.

Dunes are fragile areas, easily damaged, especially by vehicles. Every Council in the country that has policies about vehicles on beaches aims to keep vehicles off dunes.



Mostly folks driving vehicles along Waikawa Beach stick to the high-tide mark and drive slowly and carefully; in this case though the rules were broken and damage was done.

Also over Easter, on the Saturday, apparently the beach was used in a highly dangerous manner as a racetrack. I read from locals the following lightly edited exchange (names removed by me):

A: So dangerous this afternoon

B: Not sure if it was dodgem's or bull-rush trying to go down for a swim. Quadbikes to the left of me, motorbikes to the right, stuck in the middle ...

A: 8 Bikes and quads racing. Excessive speed from dunes to sea. Drivers (children) looking back to see each other so not looking forward. I was worried for their safety and my own.

C: Were people driving from the dunes to the sea or did you mean they were going parallel to the sea but filling up all the space between dunes and sea?

A: They were driving parallel to sea and filling the beach from dunes to sea

Perhaps it's time for yet another reminder, to be passed along by the many considerate drivers to those few who don't understand the law. The beach is a road (**Land Transport Act 1998**). That means that drivers must be licensed and appropriately equipped (eg wearing bike helmets) and vehicles must be registered and warranted. It also means sticking within the speed limit and obeying all other laws relating to driving on a road.

And if anyone wants to change how Waikawa Beach is used by vehicles – that falls within the scope of the Horowhenua District Council and Horizons Regional Council:

under the Land Transport: Setting of Speed Limits Rule 2017. The actual wording of the Act is that 'A road controlling authority may make any bylaw it thinks fit ... for prohibiting or restricting the use of vehicles on beaches'. Some territorial authorities have set speed limits on all beaches in their area.

**NZCPS 2010 guidance note Policy 20: Vehicle access: October 2018**

Kāpiti Council, for example, bans all motorbikes from all its beaches:

15.2 Two-wheeled (road or off-road) motorcycles or mopeds are not permitted to drive on any part of the beach.

# Foxton Beach School submission to the Horowhenua District Council Draft Speed Management Plan 2024-2034

Foxton Beach School and our Board of Trustees supports road safety improvements for vulnerable road users around our school, as follows;

1. At our entrances
2. On main pedestrian routes
3. During periods of high use by vulnerable road users.

Council has proposed 30km speed limits at Thomas Place, Carthew Tce and Hart St, Foxton Beach.

We believe Council's proposal does not adequately respond to safety concerns around the school, or for residents and visitors to Foxton Beach. Each proposed change is discussed below.

## Hart Street

There are two entrances for student access to Foxton Beach School (Figure 1). These are at:

- Thomas Place Gate
- Carthew Terrace Gate

There is NO regular access for students to the school from Hart Street. This is a locked gate used for vehicle access during special events or emergencies only, such as fire truck access (Figure 2).

Figure 3: Emergency access Hart St



The 'Strava' fitness app provides a heatmap function that highlights the routes people walk/ bike and the intensity of their use<sup>1</sup>. The Strava Heatmap in Figure 3 shows walking popularity along Hart Street is extremely low.

A reduced speed limit on this street provides no benefit to vulnerable road users or residents.

Foxton Beach School DOES NOT support a 30km speed reduction on Hart Street

<sup>1</sup> Strava users record individual routes for running/ walking and biking. The app aggregates individual's data into a global map, showing not just where people went, but the intensity in use of those routes. Routes with a high number of people and frequent use show up as "white hot" with lesser used routes shown in red. Research has shown Strava app data to be indicative of broader community behaviour.

### Thomas Place

Horowhenua District Council has undertaken road safety improvements at Thomas Place entrance gate in recent years, including crossing point and passenger set down/pickup parking (Figure 4). This has already improved safety for student access/ departure, and other vulnerable road users outside school hours.

Figure 5: Strava heatmap walking route popularity around Foxton Beach School



Vulnerable road users access the school during school days and school hours along Thomas Place and a 30km speed limit is appropriate during these times.

However Strava heatmaps (Figure 5) shows the northern portion of Thomas Place is not a high use pedestrian route, compared to other roads (Nash Parade, Bond St and Pratt Ave).

Therefore speed restrictions on Thomas Place outside of school hours does not present sufficient benefit for residents or vulnerable road users for permanent speed reduction measures.

Foxton Beach School supports a variable 30km speed limit during school time only along Thomas Place (Figure 6).

### Carthew Terrace

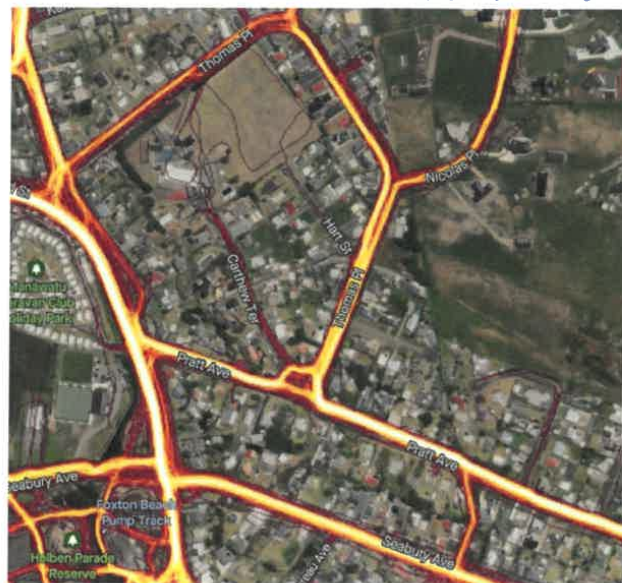
Council has proposed a 30km speed restriction on Carthew Terrace. Foxton Beach School supports this change; however we believe the speed reduction should be **extended to include Pratt Ave** from the Carthew Tce roundabout to the pedestrian walkway between 32-34 Pratt Ave that connects to Seabury Ave. This is due to:

- The large macrocarpa hedge on the Carthew roundabout corner creates a pinch point for pedestrian movement, and reduces driver visibility when exiting the roundabout onto Pratt Ave. While Council has taken measures to improve issues around the hedge, it continues to be a problem for vulnerable road users (Figure 7)
- There are multiple modes of pedestrian travel along the Pratt Ave section (bikes, scooters, walkers, prams, mobility scooters), with pedestrians travelling in opposing directions on a narrow footpath, creating movement conflicts
- Children frequently leave the footpath and travel along the road on this stretch due to the movement conflicts
- Subsequently, the section between the Carthew Tce roundabout and the pedestrian walkway at 32-34 Pratt Ave is a frequent near-miss zone for vulnerable road users
- A child on a scooter was clipped by a car at the crossing point to the Pratt Ave-to-Seabury pedestrian walkway in the 1st term of 2023, although this was likely not reported to police at the time
- Near misses with vulnerable road users occur along this section, possibly as much as on a monthly basis.
- Pratt Ave is a high use pedestrian route for Foxton Beach as shown on Strava heatmap (Figure 8).

Ideally Pratt Ave would be treated with similar traffic calming to that recently completed on Andrew/ Queen St, especially at the crossing point to the walkway.

Foxton Beach School supports a **permanent 30km speed reduction on Carthew Tce.**

Foxton Beach School requests a **permanent 30km speed reduction on Pratt Ave** from the Carthew roundabout to 34 Pratt Ave.

Foxton Beach School requests Horowhenua District Council investigate **traffic calming and safe crossing** to the walkway at 32-34 Pratt Ave.

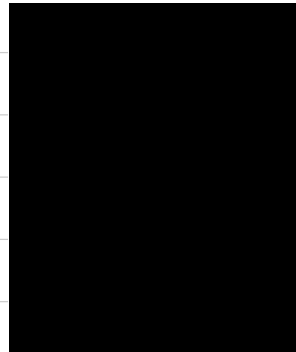

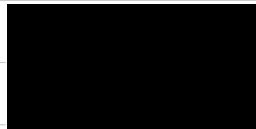

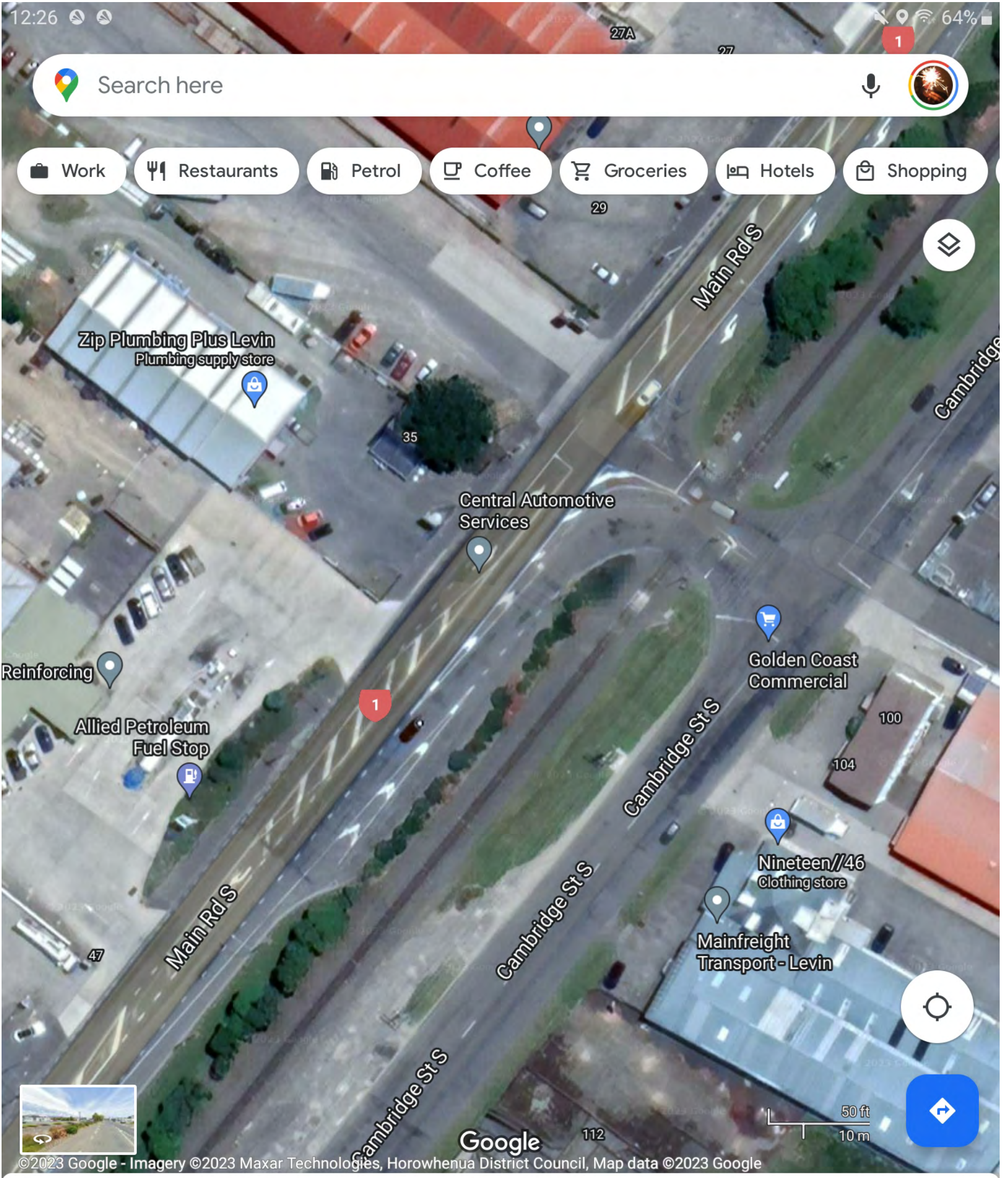

A number of areas identified have already had speed reductions. I suggest due diligence be done regarding any accidents that have occurred regarding the cause and the persons connection to the area as you can't legislate for drivers who do not adhere to road rules no matter how they are posted.

I have been going to Waikawa Beach for over 25 years and have lived there permanently for 7.  
I have been a member of Police for over 30 years also and policed road safety and attended, investigated traffic related offending.  
My opinion is that compared to other more highly densely populated areas where roads are much narrower with greater on street parking, Waikawa has quite wide streets in comparison.  
There are wide berms that people can walk on. If the council does not maintain trees and vegetation on the berms that cause people to have to go onto the road to avoid the obstructions.  
Logan horses ride on the berms here too where they can and I see this regularly too.  
The only reduction in speed in the area I know of that I was involved in as a member of the Waikawa Beach Ratepayers Assn as a committee member since moving here permanently was for taking Strathnaver Drive from 80 to 60km/h. That speed was too fast for the width of that road which for a main feeder road in the winding section is narrower than most streets in the Beach area. Strathnaver and Reay Makay Grove also have extensive berms of width for pedestrians to use and I do when walking my dog daily.

The full time residents and those who own holiday homes here do adapt their driving for holiday periods. We also 'have a word' with those May transgress with motorbikes or quads heading to the beach. Personally and professionally I do not feel that for the number of residents permanently here and the amount of traffic through here, permanent reduction of speeds within the village is not warranted

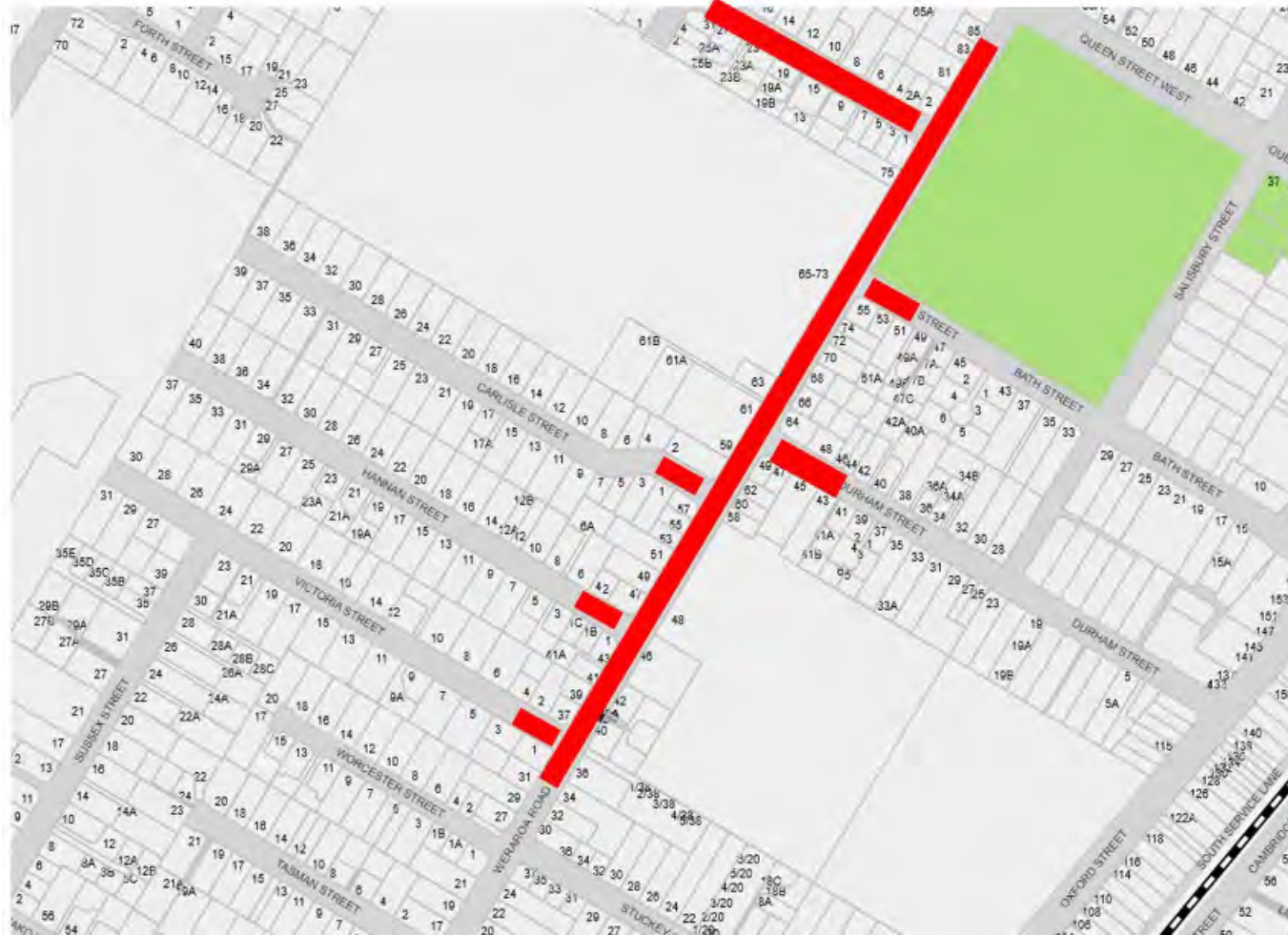

### Equity

As a result, environments do not disadvantage particular groups and so those groups do not in turn experience an unfair burden of the determinants that contribute to poor health.

Equity, as one of the principles of Te Tiriti o Waitangi, requires the Crown to commit to achieving equitable outcomes for Māori. To honour this commitment, the Crown must address and eliminate the inequities in the determinants of health and wellbeing for iwi, hapū, whānau and Māori communities.

In the New Zealand context, the population groups more likely to experience inequitable health outcomes include Māori, Pacific peoples, communities with lower socioeconomic status and marginalised groups. Other groups to experience inequities are people with disabilities and people across certain age groups, geographic locations, gender identities and sexual orientations (LGBTQIA+). Each of these groups contains people with their own unique circumstances and all of them can experience layers of disadvantage. For this reason, we need to use an intersectional lens when attempting to understand and promote health equity in the urban context.

We believe that this proposed interim plan change meets Te Whatu Ora's equity principles by providing improvements to the safety of all tamariki and their whānau, regardless of their race or chosen identity, and specifically supports those with disabilities.

### Mitigating and adapting to climate change

Climate change is the biggest health threat facing humanity (WHO 2021b). It will affect the health, equity and livelihoods of our communities and change the environment we live in.

We believe that this proposed interim plan change meets Te Whatu Ora's climate change principle by making the areas around schools safer at drop off and pick up times. It is hoped that this reduces use of vehicles and encourages active transport for whānau such as walking and cycling.

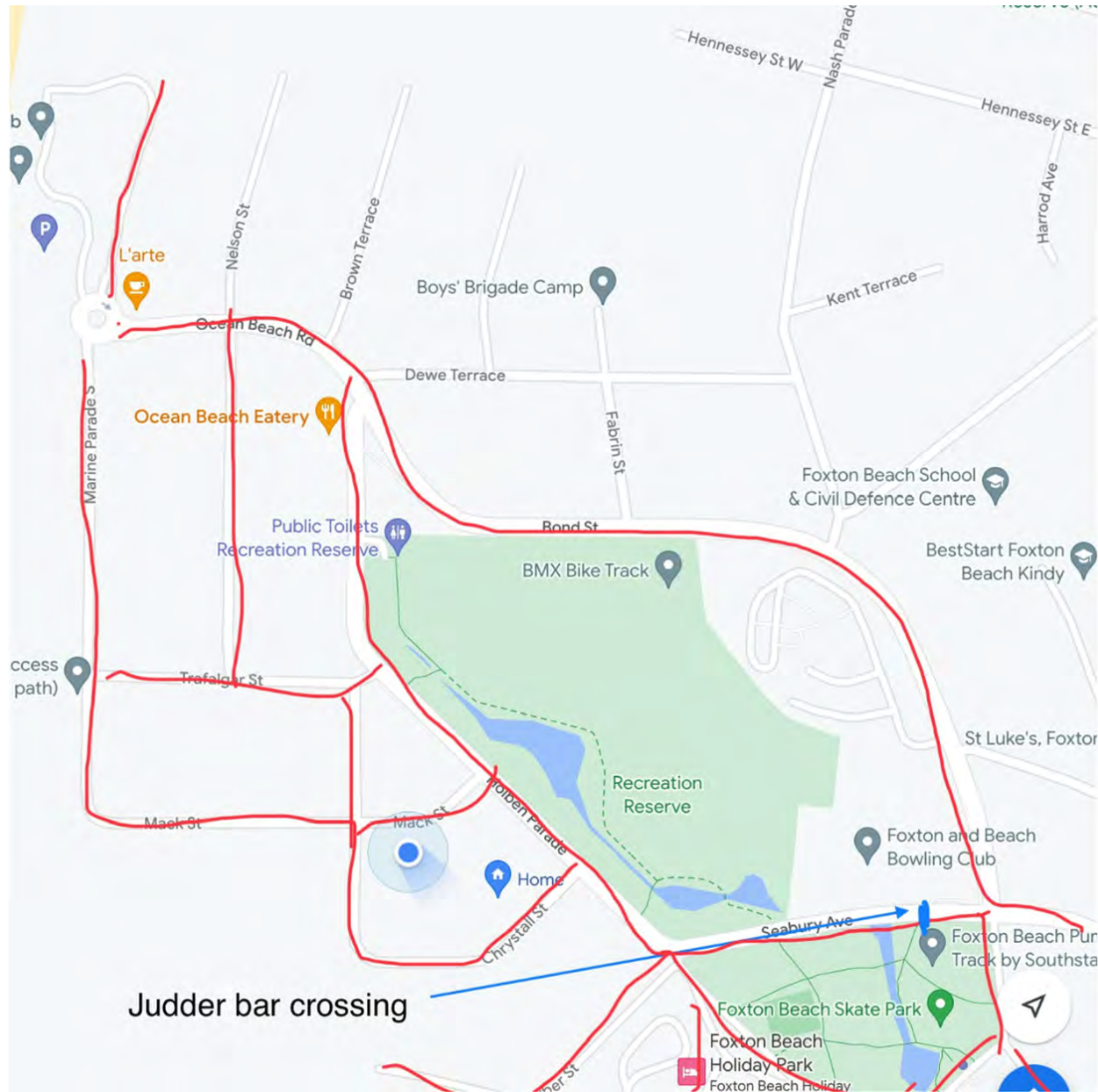
