The Mayor opened the debate on the substituted motion allowing all members to speak to it.

During debate members noted that Council is entrusted with the authority of adopting representation arrangements and setting up of general wards without recourse to a referendum and it should not be necessary to hold a referendum simply because a new ward would represent Māori.



Other proffered the view that this is a matter best decided by the voters of Horowhenua through a referendum, and by maintaining the current Horowhenua (Māori) Ward this would allow the referendum to occur.
