6.1 Waikawa Beach Accessways

The purpose of this workshop is to:

- Inform Council of what progress officers have made to date.
- Prior to coming back to Council for a decision, confirming next steps in exploring potential, alternative vehicle accessways at Waikawa Beach.
- Provide an overview of the condition of the Waikawa Beach pedestrian bridge and options for its future.
