12.00pm Local Waters Done Well Update

1.00pm Strategic Recreation Investment Framework

The purpose of the Strategic Recreation Investment Framework workshop is to continue providing updates to the Mayor and Councillors. Since our last workshop, Officers have been working with our consultants on the Framework which is now at a point that it is near completion and ready for adoption of Council. This workshop will allow the Council to see the Framework, check the weightings within the criteria and for Officer to advise of next steps.

2.30pm Waikawa Beach Pedestrian Bridge

This workshop will focus on the current condition and future planning for the Waikawa Pedestrian Footbridge informed by the Preliminary Present Value End of Life (PVEOL) Analysis engineering report that outlines the current structural integrity and options for maintenance or renewal.

3.30pm Annual Plan 2025/25 - Overview of Individual Property Impact

The purpose of this workshop is to outline the individual property impacts of the approved 2025/26 Annual Plan in advance of the rates calculated going live online at the start of June.

4.00pm Shannon Community Plan
