PURPOSE | TE PŪTAKE

- 1. This workshop is an opportunity to share and discuss the refreshed Destination Management Plan for Horowhenua before seeking formal adoption by Council on 10 September. The Destination Management Plan builds on the foundations we've already laid and reflects the aspirations of our communities, iwi/hapū partners, and visitor sector.
- 2. Council has made a series of considered decisions in recent years to strengthen our role in destination management. During the Long Term Plan deliberations, you endorsed the continuation of this function and signalled that tourism and place-based economic development have an important role to play in the future of Horowhenua. This included a modest but strategic investment to support the establishment of a destination management function, recognising the benefits of telling a stronger story about our district, supporting local businesses, and protecting what makes this place special.
- 3. The work to date has been supported through Better Off funding, which has allowed us to stand up the function and deliver some of the early building blocks including a destination brand, digital strategy, visitor content, signage upgrades, and sector engagement. With those foundations in place, the refreshed Destination Management Plan sets the direction for the next phase.
- 4. This workshop will walk you through the refreshed plan what's changed, what we've heard from stakeholders, what we've learned along the way, and how we propose to deliver value from here. The DMP reflects new opportunities and challenges, including our growth as a district, the economic contribution from the visitor sector and how this is trending, our recent decision to become an associate regional tourism organisation and the potential this provides Horowhenua.
- 5. We recognise this comes at a time of heightened political awareness ahead of local government elections and in the context of the recent Local Government Amendment Bill and will look to share more about the national context for the visitor sector.
- 6. We welcome your input and questions ahead of the Council Meeting on 10 September and ask that you consider the following questions in preparation for the workshop..
- 7. Questions:
 - 7.1. What role do you see the visitor sector playing in growing the local economy?
 - 7.2. What do you see as the strategic opportunities and challenges for Destination Management in Horowhenua?
