- 3. A number of items of concern around granting of a key and access to the Lake by the Levin Sea Scouts last week have been identified which would have some of us Muaūpoko lwi Representatives request a return of the keys by the Sea Scouts and a 'pause' on the Sea Scouts use of the lake.
- 4. This request is being made to enable discussions amongst the Board and with the Lake Trustees to occur prior to a whakawatea in conjunction with or ahead of a reopening of the Horowhenua Lake Domain for use by the public and groups including the Sea Scouts.
- The rāhui has been lifted but a whakawatea is required. Granting of access by the
 public or groups including the Sea Scouts prior to tikanga being observed constitutes a
 whati tikanga.



- We are awaiting receipt of the health and safety review for discussion at Thursday's meeting

A. DRAFT LAKE DOMAIN (MUAŪPOKO PARK) DEVELOPMENT PLAN 2024- 2034

PURPOSE

The purpose of this plan is to outline the moemoeā the Lake Domain Board have of the area of which they oversee.

It will highlight the goals the Board wants to achieve over the next 10 years in the hopes of creating an environment that whānau and the wider community can enjoy and are proud of.

This plan will look at the actions required to meet these goals and the management of the Lake Domain in the Board's role of Kaitiaki.

THE AREA

Offering great views over Lake Horowhenua, Muaūpoko Park is an extensively landscaped area of parkland around the lake with a playground. Lake Horowhenua is one of the coastal dune lakes typical of the region.

A large variety of bird life visits the lake - a great place to feed the ducks with the littlies. It is a peaceful spot with play equipment and large grassed areas.



No power boats are allowed and the lake is not suitable for swimming. Dogs only allowed in designated Agility/Obedience Club areas.

Muaūpoko Park has previously been maintained by Horowhenua District Council under the direction of the Lake Domain Board, vehicle access cannot be guaranteed although the park can be entered by foot from the Queen St entrance.

NGĀ MOEMOEĀ

- Muaūpoko Park is a safe space for whānau and the wider community to enjoy recreational activities, whakawhanaungatanga and the wairua of Muaūpoko.
- A park that represents the biodiversity and ecology of Muaūpoko and contributes to improving the health of Lake Te Wai o Punahau.
- An educational area for whānau whānui to learn from.
- Trust base-core is the health of the lake.

THE PLAN

Short Term until 1 July 2025

- Apply for external funding to support kaitiakitanga of the space
- Community clean up effort to mow learns, weed and pick up rubbish.
- Put in a gate at the entrance to the park
- Get a security installed for the front of the park, at the entrance.

Medium Term until 2029

- Clearer lines of sight, with trees trimmed or removed
- Riparian planting along the streams that go through the domain
- A full time kaitiaki of Muaūpoko Park who cares for the park and ensures those who are
 enjoying it do so in a safe manner.
- Improved amenities
- Ongoing maintenance of the amenities and open spaces.

Long Term until 2034

- An area for whānau hui and celebrations with power source for lighting, speakers etc.
- Raised hāngi pit
- An event centre

DISCUSSION | HE MATAPAKINGA

- 2. At the recent local body elections, Board Member Jonathan Procter did not seek reelection as a Councillor.
- 3. While Professor Proctor was a Council appointee, he remains a member of the Board notwithstanding him no longer being an elected Councillor because his appointment, like all board members, is a ministerial appointment.
- 4. The governing Act of the Board provides for three people recommended by the Horowhenua District Council to be appointed to the Board. There is no requirement for them

to be an elected member, although traditionally this has been the case, and is a matter for Council to decide

- 5. Should the Horowhenua District Council recommend someone else to replace Professor Procter this will need to go the Minister of Conversation for appointment.
- 6. Officers will advise the Board if and when such recommendation is made, and when any appointment is made by the Minister.
